**Successful Global Health Initiative Conference Held in August**

Dr. Margaret Soderberg, Division Global Health Chair, reported "We held our Global Health Initiative Conference 'The Global Burden of Disease—Not Just In Developing Countries' on August 16th. Topics were directly aligned with the UN Millennium Development Goals.

Those who attended heard "The Plight of the Children of the World Orphaned by AIDS" from Dr Ruth Hayward. Michael Gottlieb, MD who reported the first cases of AIDS in the United States, presented the statistics of the

exponential growth of this deadly pandemic.

Stephen Waterman, MD of the CDC spoke about malaria and other vector borne diseases.

Dr. Jan Singh of the TB Control Project of the LA County Public Health Department said Los Angeles could rank as a 5th state in the incidence of TB.

Dr. David Diaz-Sanchez of the EPA shared the fact that particulates of air pollution in Beijing were at levels 5 times that of what he is allowed to expose volunteers.

Keynote speaker, Marcy Zwelling, MD, defined issues of National Health Insurance. We came away with a financial surplus and thanks to my committee members and many others who made the conference a success."
